Dear Sunrise Campers and Parents/Guardians,

Camp Sunrise registration is upon us. We have been working diligently to ensure this summer will be amazing!

We offer campers a variety of activities including climbing on our climbing tower, canoeing, bowling, hiking, campfires and more! In addition, this year we are pleased to once again offer two trips to the nearby Winslow Therapeutic Riding Center (Week 2 and Week 4).

If you would like to register for camp, please fill out the following forms and return them by mail as soon as possible to secure your spot in the week of your choice: Camp Sunrise Registration Form, Health Form and Camper Information Form.

In addition to these forms, please also provide a copy of the camper's immunization record from the doctor's office, proof of TB test (*TB test must be administered within TWO YEARS of camp start date*), and a copy of the camper's Health Insurance and Prescription card(s).

If you are interested in participating in the optional Winslow Saddle-Up daily program, please include the payment of \$55 with your registration packet and we will send you additional waiver papers with your confirmation documents.

Campers will be able to register for no more than TWO weeks of Camp Sunrise during the initial registration period (if space is available). The initial registration period will last until April 13th. Any campers wishing to register for more than 2 weeks will be placed on a waiting list for additional weeks. After April 13th, registration requests for additional weeks will be processed in wait list order.

Payment in full is due at the time of registration. ALL needed forms and supporting documents are to be completed and mailed to the Camp Registrar. If payment is to be made by an agency, please provide us with all information.

INCOMPLETE OR PARTIAL REGISTRATIONS WILL NOT BE CONSIDERED.

You will be notified of your acceptance into the program. Acceptance is made on a first-come, first-served basis upon the complete submission of the above forms and payment. Notification should take no longer than three weeks.

The Authorization for Administering Prescription and OTC Medications form will be included with your confirmation packet. This form must be signed by the camper's physician and mailed back so we receive it **no later than June 1, 2018.** *Please do not hold the form and bring it with you at check-in. All waiver forms, including Winslow Riding Forms and Medication Forms need to be received by June 1st, prior to the start of the 2018 camp season. Any camper who lacks the Medication Authorization paperwork cannot be accommodated at Camp Sunrise, and no refunds will be given in this case. Note: If the camper has a change in medications between June 1st and the week they are attending camp, please contact the Camp Registrar.*
